# The STICHTING EVANGELISCH ONDERWIJS EINDHOVEN (to which the EBS Online belongs) knows the following principles and objective:

### PRINCIPLES

(article 1) The foundation uses the evangelical principles as a guideline for all their activities, by which de foundation means the following:

- a. The unity of God, from eternity being three persons in one: Father, Son and Holy Spirit.
- b. The sovereignty of God the Father in creation, providence, revelation and completion.
- c. Our Lord Jesus Christ, God revealed in the flesh, born from a virgin. His sinless life, His divine miracles, His substitute and redeeming death, His physical resurrection and ascension, His work as an intercessor and His personal return in might and glory.
- d. The divine inspiration of the Holy Scriptures and, flowing from it, its reliability and highest authority in all matters of faith and life; there is no fault in all it declares.
  - The universal and total sinfulness and guilt of fallen man, that subject him to the wrath and judgement of God.
  - The redemption of sinners through the blood of Jesus Christ, God's son and their justification out of mercy, not by works, but through faith in Him.
- g. The physical resurrection of the dead; of those who believe to eternal life and of those who are lost, to eternal judgement.
- h. The work of God, the Holy Spirit, Who enlightens the mind, Who works rebirth and lives inside a believer, Who enables him to lead a holy life and to testify and to work for the Lord Jesus Christ.
- i. The priesthood of all believers who together form the universal congregation, the body of Christ or which He is the head and that is, by His orders, obligated to testify of the gospel to the entire world

#### **OBJECTIVE**

f.

The objective of the foundation (article 2) is the giving or the attributing to the giving of education from this evangelical belief/point of view and in the execution of it (article 3) bases itself on the evangelical principle that the emphasis of the education and societal life should be on the personal relationship with God through Jesus Christ as key to understanding all God has revealed in His word and works and from that the knowable reality. Upbringing and education should be in line with this and should, among other things, serve to bring both children and adults to God as well as make them grow in relationship with God and all that flows from this.

#### Procedure

After reception of this application form you'll receive a confirmation from us by email. If there are no siblings attending our school yet, the principle of the school will contact you for a meeting to get further acquainted. The enrolment of your child is only definitive after this meeting has taken place, the school has received a fully filled out and signed application form and EBS Online has formally confirmed the enrolment.

#### Need for support

School would like to indicate that parents have the legal obligation to inform the school at the moment they apply regarding any relevant information necessary to determine the need for support of your child.

#### Yearly parent contribution

Each fall you will receive an invoice for the parent contribution for the current school year. The parent contribution is established at 50 euro per child per school year, with a maximum of 125 euro per family per year. By signing this application form, you agree to paying this contribution. Your child will never be excluded from activities due to non-payment of the parental contribution.

#### Statement of consent

By signing this application form, you consent to the data exchange between EBS Online and the applicable organisations (like daycare centre, peuterspeelzaal, host family, Zuidzorg, GGD, current/previous primary school) that is relevant for the enrolment procedure.

#### This application form is to be signed by both parents.

#### What if you are divorced?

- In case of co-parenting, <u>both</u> parents must sign.
- In all other cases it is the parent/caretaker the child is living with who signs. If this is the case the school additionally needs a copy of the declaration that specifies who has the legal authority over the child.

#### Parentportal/Ouderportaal

As soon as your child starts at our school, you will receive login credentials and information from us regarding the application Parentportal/Ouderportaal, which we use to communicate with parents. Parents themselves are responsible for entering the correct contact information into this application, and for the upkeep of this information, and retain ownership over it. You as a parent have the choice whether or not you make this information visible to other parents. The school does have access to this information, but is legally prohibited from sharing it with other parents without your explicit permission.

Among other things, through Ouderportaal we ask you to which extent you grant us permission to share footage (pictures and/or video's) of your child, for example for our bi-weekly newsletter, for our brochure or on our social media. As long as you don't grant us this permission, we will not share any footage of your child in any of these situations or other.
